Bug Fixes

- Several misspelled words in Chart Summary Report fixed as well as "unknown" in family history tab
- When adding a new patient warning, the current patient chart # will automatically populate the field avoiding the need to search for and select the patient
- Inactive Health maintenance guides will no longer show in the list of guides unless you check the box for them to show
- From the deleted tab in Care Team, Delete Permanently will now do just that, it was moving that provider back to Providers tab previously
- In Chief Complaints, if a user free texts an answer when there is a drop-down menu, the answer will no longer become part of the list for future entries and only remain on that one patient instead.
- You can now add more than one filter to the Patient List Report without the system crashing
- When you add clinical assessment custom fields it no longer displays as one per line in the assessment area
- Close forms message has been reworded to read "please ensure all tabs are closed" in the following areas: archive patients, profile storage settings, multimedia storage settings
- Notes Tab and Unsigned Notes Report
 - customizations made to this screen are now saving correctly
 - Address, city, state and zip have been removed from this screen
 - Chief complaint has been added
- DNR value lab results are no longer appearing in the lab review bin, nor requiring a signature
- Procedure codes now remain checked in electronic superbill when going back to review after saving
- Enhancements have been made to the image editor that opens when double clicking the image from the Note. Also, if you add an image to a note guide it will not move when you edit the image in a Note

New Features

- Patient home phone number has been added to the column chooser in the Schedule view on the dashboard.
- When signing off on a note, time stamp will not read the user code but instead the user's full name
- Added "patient portal" as an option in the demographics screen as a preferred contact method
- If an allergy has multiple reactions and severities, they will now be displayed on the allergy summary screen
- Unsigned Notes Report – this now opens each note as a tab instead of a window so that it can be worked without closing and reopening after each note is reviewed
- Task List columns on dashboard – patient name has been added as a column on the task window of the dashboard and shows by default
- Ability to multi select faxes to delete using CTRL or SHIFT keys has been added

- Note Comparing – when creating a new note, you can now pull up an old one beside it and copy parts or all of the old note over to the new one, make changes before signing.
- Within Electronic Superbills, on the selections tab, users can now choose the ***select all*** button to assign all diagnosis codes to the CPT
- Filter added to Tasks (and tasks on dashboard) that is **on** by default to filter out completed tasks
- Fax button added to Order screen, allowing users to fax the attachment directly from this screen
- Fax button added to Print Full Chart feature, allowing users to fax the attachment directly from this screen
- Send Message button added to Print Full Chart feature, will attach a PDF of the report and open a new message pop out window
- Can now add care plan from macros and history button in notes
